#### Notice: Discontinuation of Summer 1 & 2 for Non-final Year courses

29 September 2022

The University has made some major changes in the Exam processes and these are applicable to all students of the University from the Academic Year 2022-23.

#### Non-Final Year Courses

1. For non-final year courses the Summer 1 and Summer 2 examinations shall cease to exist.
2. The University shall continue to have Repeat Category but would be offered during normal teaching semesters.
3. The Repeat category (due to student being debarred in the regular exams due to attendance and/or marks) shall be taken as a Repeat through a Guided Self Study Course (GSSC) at end of which the student would also take the exam. **In this case the student's previous internal marks shall stand null and void.**
4. **Repeat with GSSC** (Compulsory & Optional) is applicable in case of-
  - A) Repeat Compulsory - If the previous exam result status is Debarred (DB) due to attendance (all programmes)
  - B) Repeat Optional - Any student who has failed a subject and who wants to improve upon their previous internal marks need to repeat the course (Not applicable for B.Pharm)
  - C) Repeat Compulsory - Exam result status Debarred (DB) due to less than pass marks (50%) in internal (applicable only for B.Arch- upto 2019 batch admissions)
5. The faculty allocated for the GSSC has to certify and submit to the exams office that the student has met all requirements for the GSSC. Faculty shall maintain and monitor the logbook for attendance and shall note the student interactions. This shall be accounted for a student's minimum requirement of attendance i.e. 75% during the semester for above categories.
6. The Time-Table for Repeat Category shall be merged with the regular Semester Time-Table; hence, identification of such dedicated hourly slots would be done by the respective schools. Dean and Dean's Office shall monitor the overall Time-Table in order to avoid clashes
7. Examination of Repeat/Reappear shall be accommodated with the End Semester Examinations.

#### Final Year Courses

8. Additional attempt at Repeat and Reappear shall be offered to the graduating students so that they have the opportunity to graduate during the same year. Summers for graduating students (**courses of final year Odd & Even semesters**) shall be conducted from mid-July, which shall have 3-Weeks of Classes and 2-Weeks of Exams.
9. **Repeat** (Compulsory & Optional) is applicable in case of -
  - A) Repeat Compulsory - If the previous exam result status is Debarred (DB) due to attendance (all programmes)
  - B) Repeat Optional - Any student who has failed a subject and who wants to improve upon their previous internal marks need to repeat the course (Not applicable for B.Pharm)
  - C) Repeat Compulsory - Exam result status Debarred (DB) due to less than pass marks (50%) in internal (applicable only for B.Arch- upto 2019 batch admissions)



In the Repeat category students are required to repeat the course. This would be through a fast track mode wherein the student would be required to attend classes and at end of which the student would also take the exam. Minimum 75% attendance is required in the course conducted during Summers for the student to be eligible to take the exam. **In this case the student's previous internal marks shall stand null and void** and only the current internal & external marks would be considered.

**Reappear & Improvement**

10. As the Summers would be discontinued (except for the Final Year Courses) the Reappear & Improvement exams would be offered only during Odd & Even Regular exams.
11. However, B.Pharm programme will have, additionally, Reappear examinations for non-graduating students in Summers from mid-July to accommodate minimum number of attempts to clear a paper as prescribed by PCI norms. (not applicable to other programmes)
