GUIDELINES FOR ABSTRACT/PAPER:

The text must be in MS Word with Times New Roman 12 point font single space. The Abstract/Paper should contain Title of study (font 14) in top centre with bold followed with names of the authors (presenting author name should be marked with asterisk), affiliations and email address. Keywords must be included. The body of the Paper should contain brief introduction, methodology, results and conclusion. The names, email, phone numbers and institutional affiliation of the authors should be mentioned at the parenthesis.

*Full length paper will be published in ISBN conference proceedings.

Submit the abstract through email <u>nationalconferencesu@gmail.com</u> on or before 10th March, 2023 only. Acceptance of the abstract shall be communicated latest by 13th March, 2023

GUIDELINES FOR POSTER PRESENTATION:

The poster (80 cm height and 120 cm width) should be printed on vinyl or equivalently good material. The poster should include following sections: Introduction. Material and Methods, Results, Discussion, Conclusion and References. At the bottom: National Conference, 31st March, 2023, Sushant University, Gurugram (HR) should be printed.
