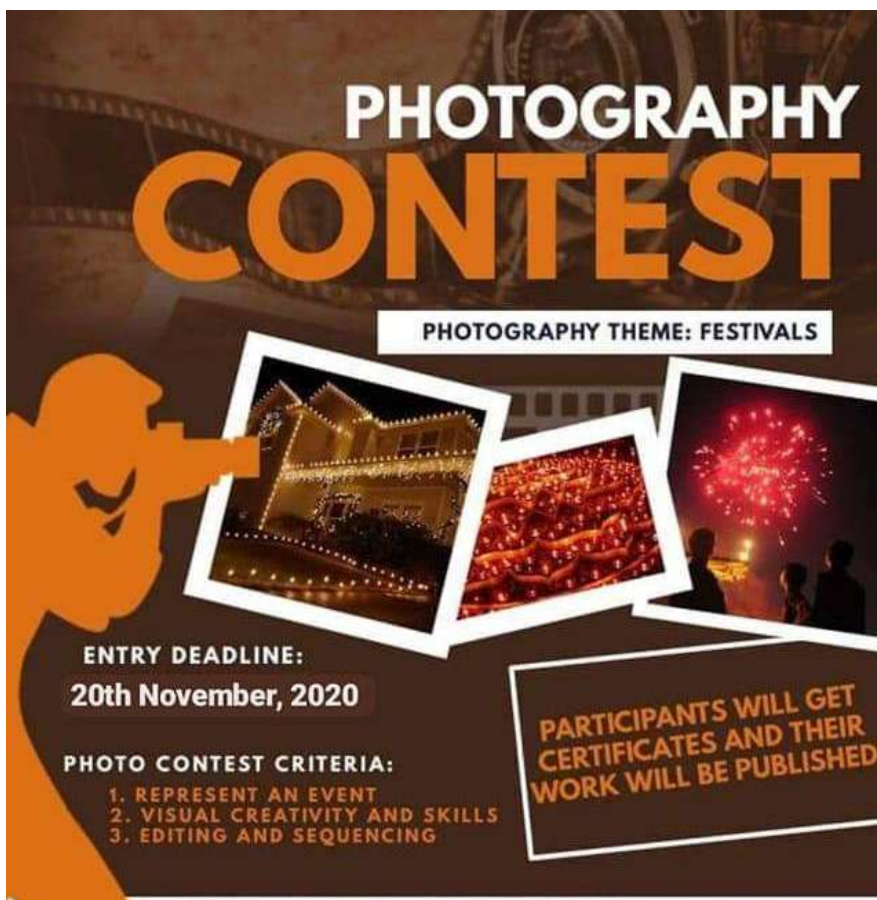

A SHORT STORY-“THE BRIBE”

Kedar Sinha worked in the local municipal office. At the office he was the UDC or the upper divisional clerk in-charge of licensing of small trade such as local tea shops and the like.

At home he was the father of two daughters, a son and a husband to one nagging wife. His life revolved around his family and his work. His place of importance in his colony was second only to that of the havaladar who stayed two blocks away. The only difference being in the fact that the havaladar went to the thana on the scooter and Kedar Sinha took the 8:30 am bus. Virtues such as punctuality, neatness, politeness and above all honesty were kept alive by the likes of Kedar Sinha in the municipal office.

The newspapers would time and again keep publishing articles calling the municipal office the hotbed of all corruption in the city. But Kedar Sinha never got to see any of it. Like the others he read the newspapers and joined his colleagues in ridiculing the article and its author.

Kedar Sinha arrived one morning at the office. He had prayed to God all along during the 20 minute bus journey. He had prayed that the administrative officer would be there and the cashier would not have

decided to take the day off. The new academic year had started and the children's school admission fees had to be paid, new books and new school uniforms to be bought. The pay was already half spent and the only hope now was the emergency fund. A clerk in his grade was entitled to Rs.500/- advance on the salary, to be deducted from the next month's salary. The peon told him the administrative officer was in and Kedar could see him in half an hour's time. God had answered his prayers, the accounts officer was there too.

Half an hour later, Kedar Sinha walked in to the administrative officer Mr. Sinha's office. "Yes, Kedarjee", he said, "What it?" Kedar started with the pleasantries, "Good day to you sir." "The newspapers have printed about the excellent facilities we provided to the Yuva Mandal Mela this year. They printed your name commending your excellent organizational abilities".

Kedar knew very well the Yuva Mandal Mela this year had been organised under the patronage of the local MLA and Municipal Corporator. If anything had gone wrong heads would have rolled in the municipal office. Mr. Singh had taken the whole responsibility on himself and no expense was spared. But all this was unnecessary. The advance was important. "Yes, yes that's okay but.... is there any problem or any file you want me to see?" Mr. Singh asked. "No sir, I am having financial problems sir. Could you help please? You see the new academic year and all that....Sir."

Kedar came out two minutes later. The advance had been refused, Mr. Singh's explanation being the fund was meant for emergency use only and the cashier had informed him that Kedar and the others were using this quite regularly and this could not be tolerated any longer. An example had to be set and rules enforced tightly.

Two days later Kedar received letters from the school informing him that the fees had not been paid and he should do earliest. Everybody in the office knew his plight, but no one said anything.

When he reached the office on Monday morning he saw two people standing near his table. "What is it?" he asked.

One of them started off. "Sir we had filled two forms about opening a small restaurant near the sabzi mandi area. But it has not been cleared yet." Kedar checked a register on his table that contained a record of all forms submitted to him and said "The old mandi area is already crowded and the sanitation is poor. Permission, therefore, is not granted." The two men looked at other. The flattering smiles did not leave their faces for a second. "Sir we have already ordered the kitchen equipment, please sir can you reconsider?" "What even if I did the, the health department will not grant you permission."

"But sir they have." One of them opened a file cover that he was carrying and produced a sheet of paper: it was a letter giving the go ahead from the health department.

Kedar knew people had been paid. The letter from the health department was a fine specimen of corruption. "Sir, maybe this will help," one of the men said producing an envelope from his pocket. Kedar took the envelope. He knew very well what was inside it. This was how it was done in the movies. He looked quietly to his left and then slowly right to his right. Everybody was busy in their work.

Kedar pocketed it.

The books, the uniform would come today in the evening. The school fees would be paid in the morning. Kedar finished their work in ten minutes. The license was filled and stamped by him in two minutes.

Corruption had always been there in the municipal office and Kedar knew it. He now knew how Verma, the accounts clerk got his scooter and how Raman, the peon smoked cigarettes and not the traditional beedis.

On his way to the market he kept wondering how much he would find in the envelope. He has not gathered the courage to check the contents of the envelope. According to him the work he had done was worth at least a thousand rupees. He reached the bookshop. He would buy his children brand new books and not the usual second hand ones. In about twenty minutes, the books had been packed. He had even bought the colour pencils his daughter kept asking for. Now for the payment, he took the envelope out. His hands were a little sweaty as he opened it. Inside was a folded sheet of paper. Oh God a cheque! Kedar thought. This would complicate matters. He unfolded it.

There on the letter head of the local MLA was a letter addressed to Mr. Singh, the administrative officer, telling him to look into the restaurant matter personally and to ensure that the municipal license was granted to these two members of his constituency. Mr. Singh had signed it and put a handwritten note on the side asking Kedar to issue the license without any delay.

Ignoring the calls of the shopkeeper Kedar Sinha slowly turned and walked away.
