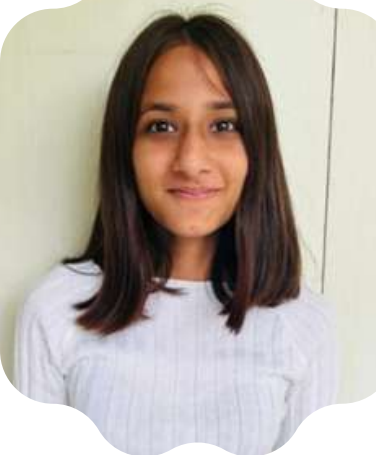

The course has also enabled the students to conceptualise ‘What is Law?’ and how it is omnipresent, academically and professionally. It has transgressed the contours of the five-years integrated B.A.LL.B., B.B.A.LL.B. and three years LL.B programme.

The pedagogy of the programme was diversified including Online Lectures, Documentaries, PPTs, Group discussions, Debates, Expert talks to name a few. The course has been designed and coordinated by Ms. Anushka Choudhary under the able guidance of Prof. (Dr.) Anil Dawra.

PRARAMBH 2023

School of Law, Sushant University organized an Orientation Programme 'Prarambh 2023 – Navigating New Horizons Together' for the newly admitted BA LLB ,BBA LLB & LLB students on 14th to 18th August, 2023. The major objective of the programme was to make the students aware of the academic aspects of the course and the rules and regulations of the University and also to familiarize the newcomers with the academic enhancement, and support services available, ultimately facilitating a smooth transition into university life. The orientation program began on 14th August with a wonderful welcome speech and the importance of opting Law as a career in today's era by Prof.(Dr.) Jagbir Singh Dahiya. 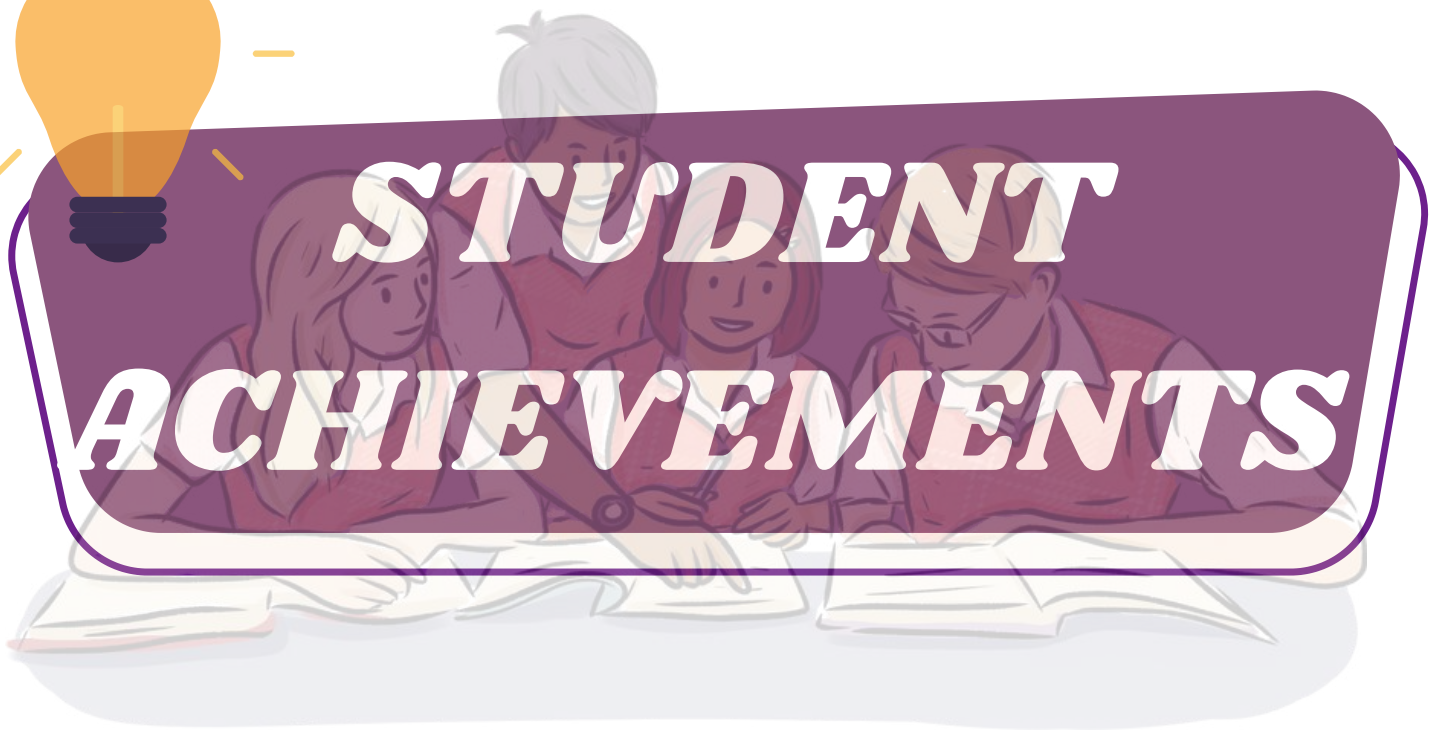
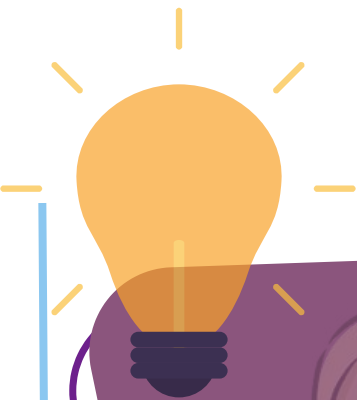

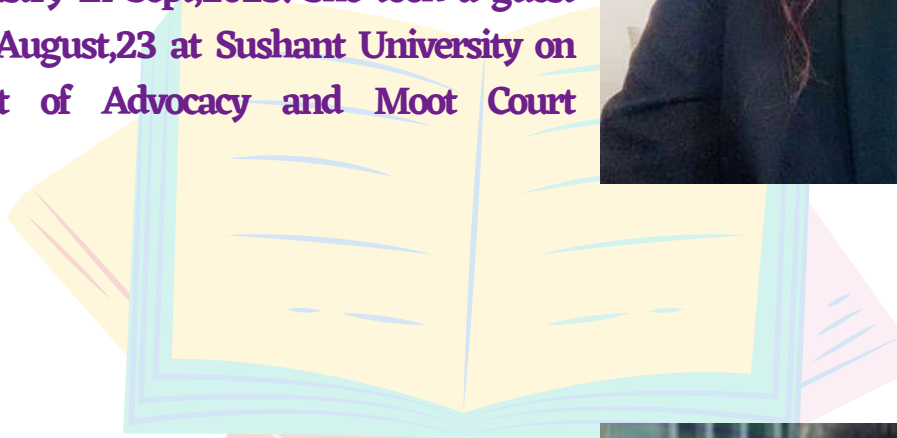
STUDENT ACHIEVEMENTS

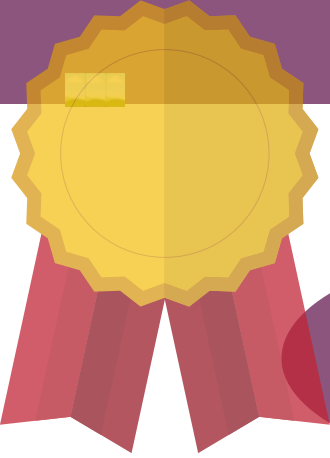
