


# REPUBLIC DAY CELEBRATION

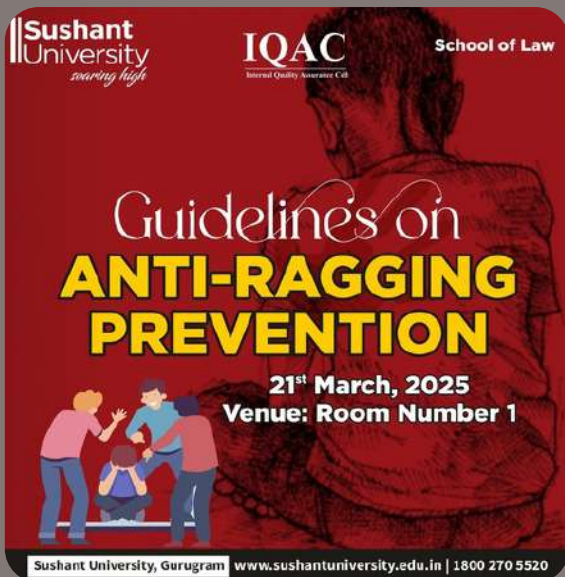
# WORKSHOP ON SECURITY MARKET AND GRIEVANCE REDRESSAL PROCEDURE

# ANTI-RAGGING PREVENTION

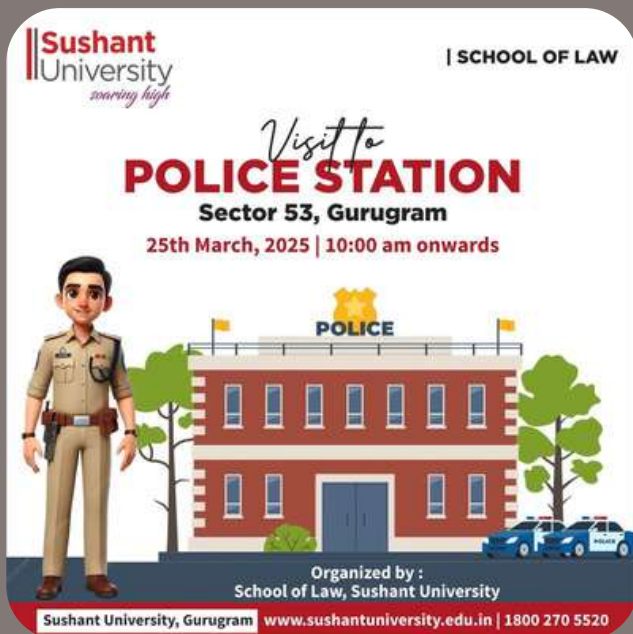

# POLICE STATION VISIT
