

Dr. Sulakshana Banerjee, Associate Professor of Law wholeheartedly worked for attaining these rankings on behalf of the School of Law, Sushant University.








WORKSHOP ON FUNDAMENTAL RIGHTS




WORLD INTELLECTUAL PROPERTY DAY

WORKSHOP ON IMPORTANCE OF LANGUAGE AND LITERATURE






FIVE- DAY INTERNATIONAL FACULTY DEVELOPMENT PROGRAMME


Valedictory Session Speaker: Dr. G. Uma
