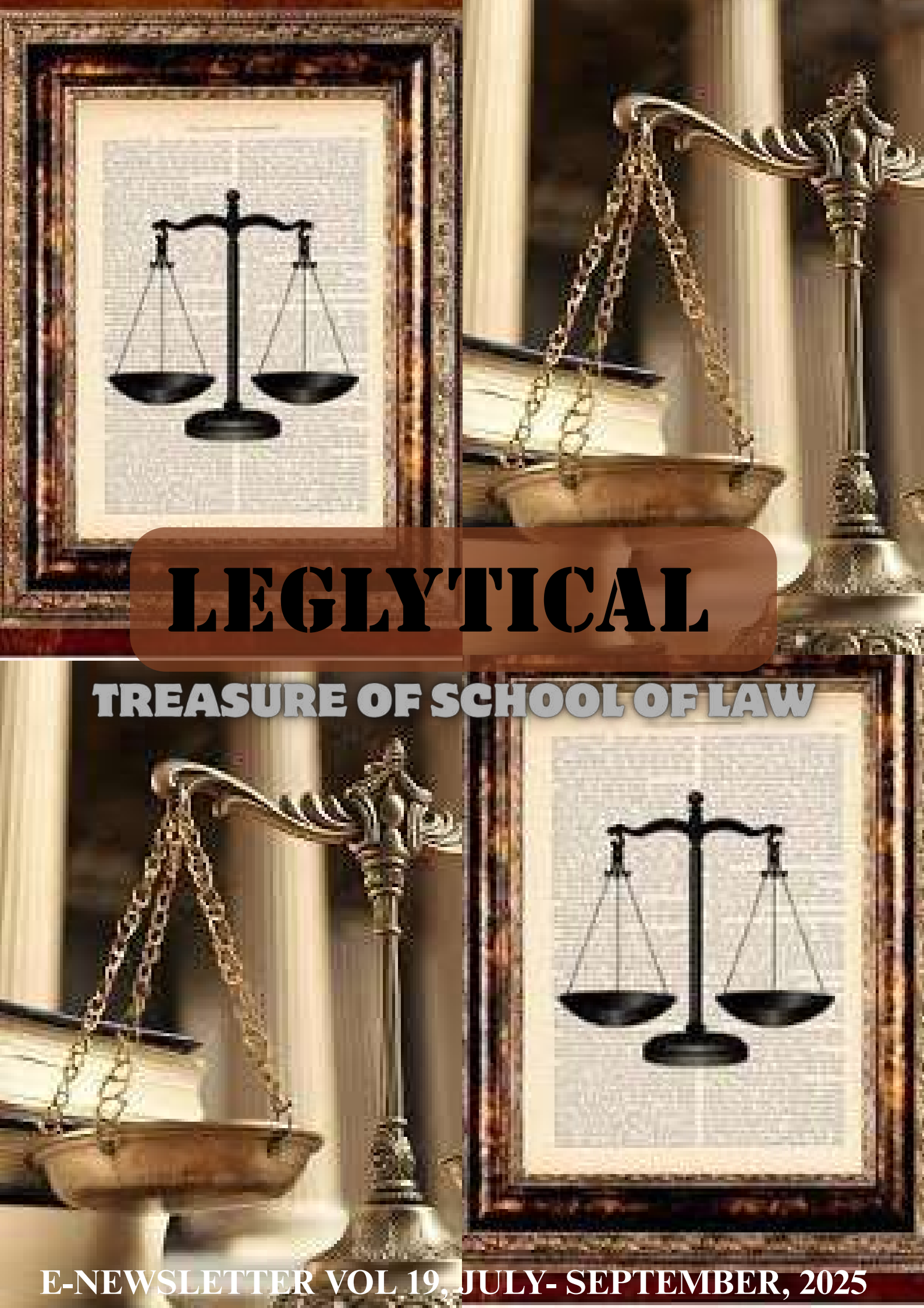

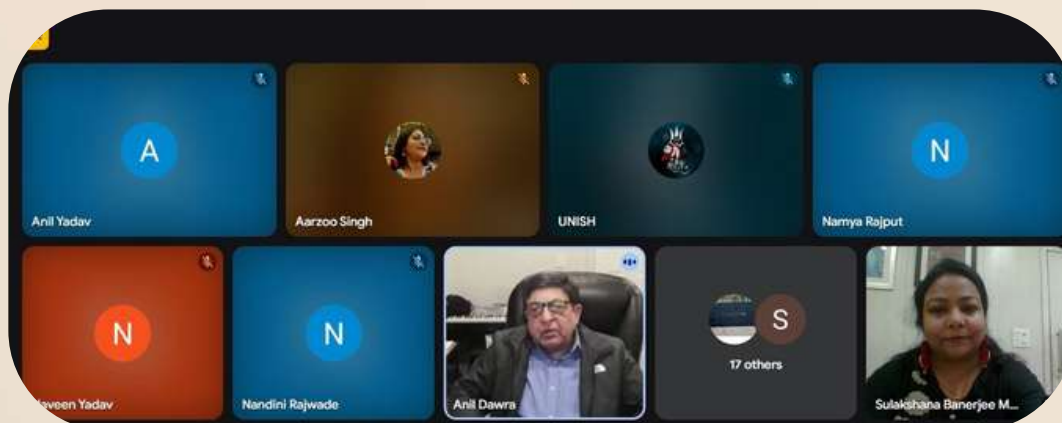
DAY-1

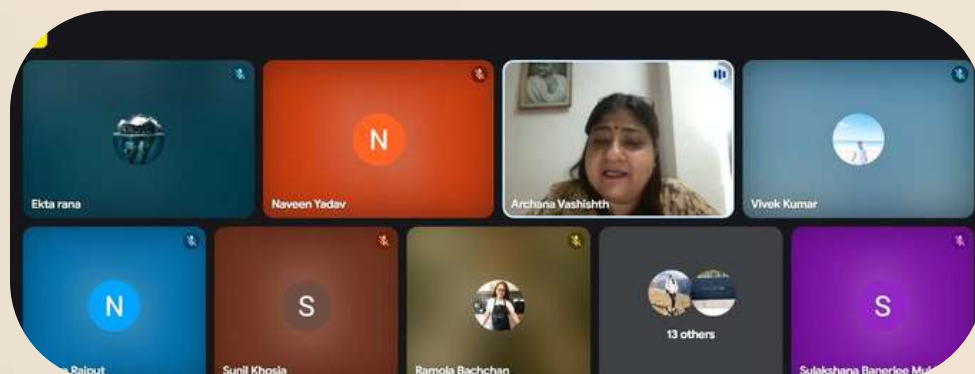
DAY-5

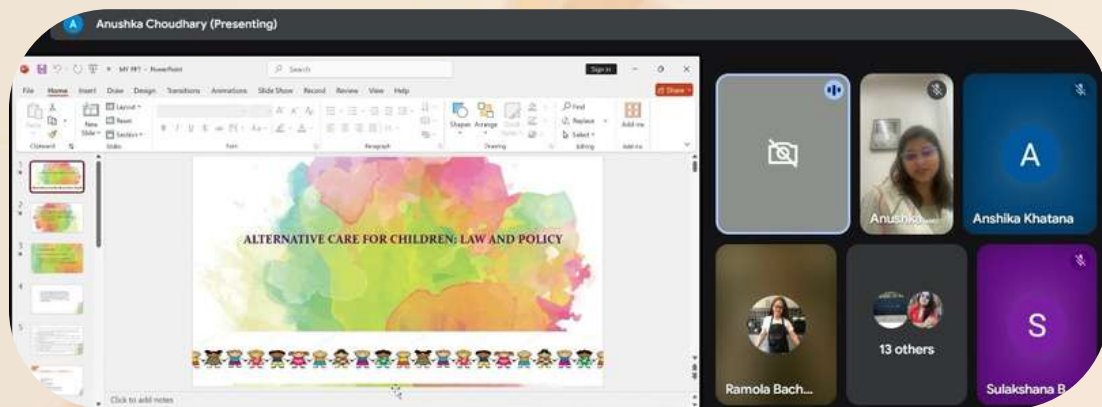
DAY-6

Independence Day Celebration



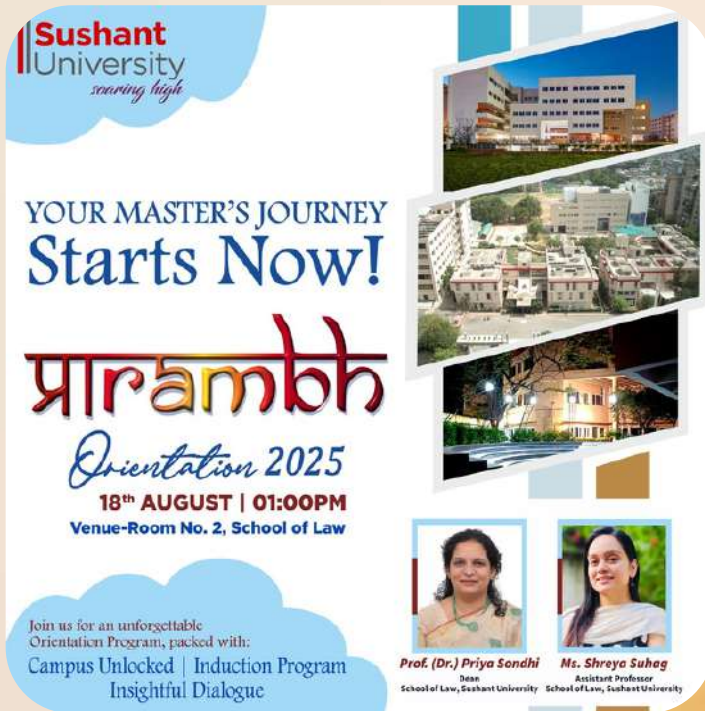

LLM Orientation Programme



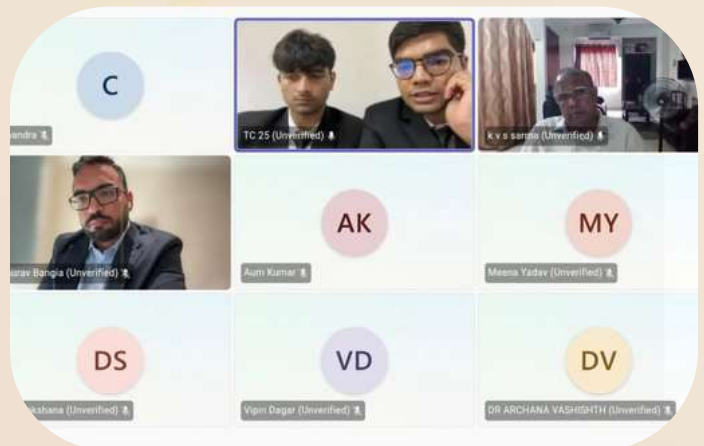
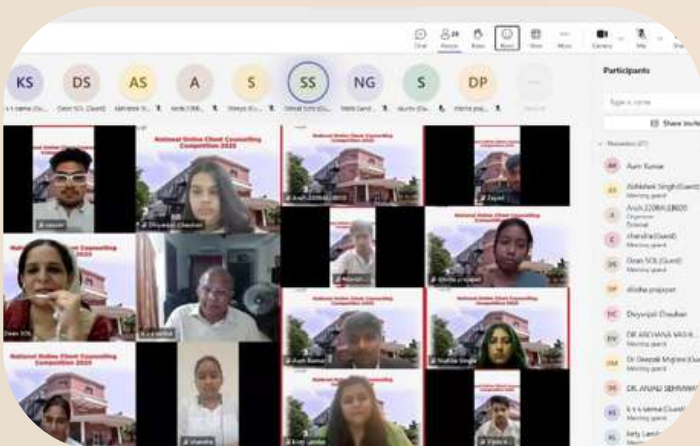

National Online Client Counselling Competition, 2025

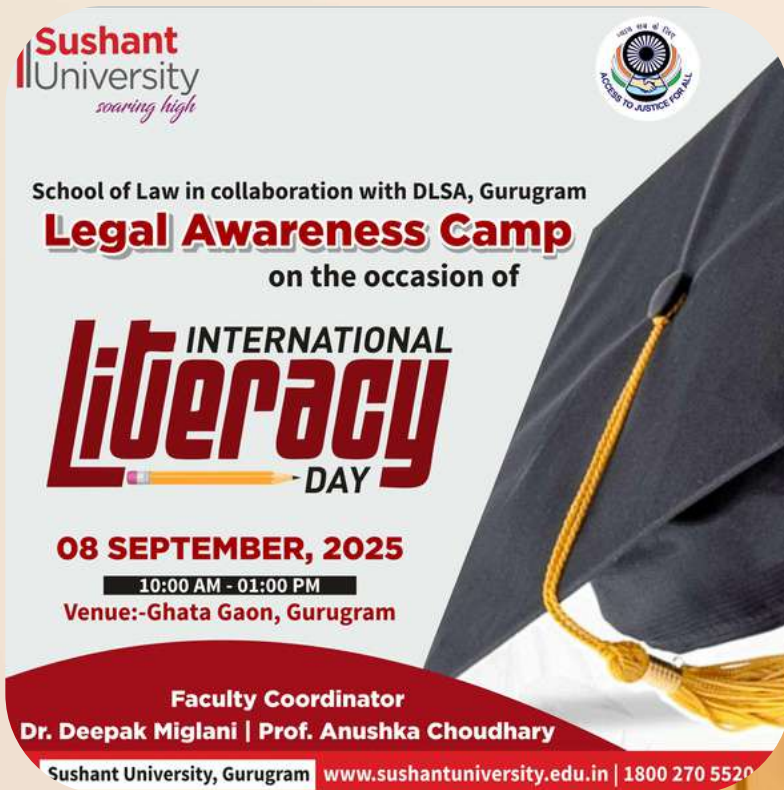
