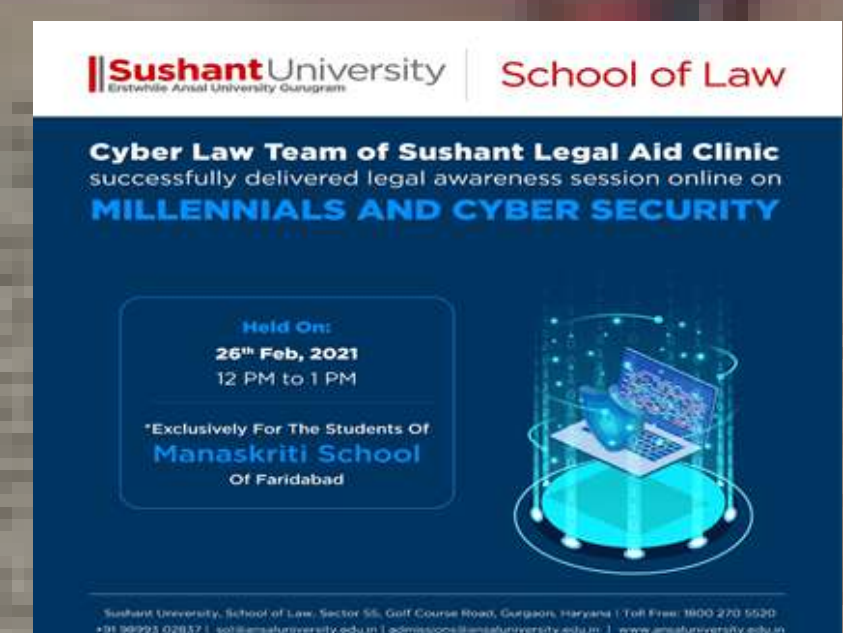
Sports Event-Blaze

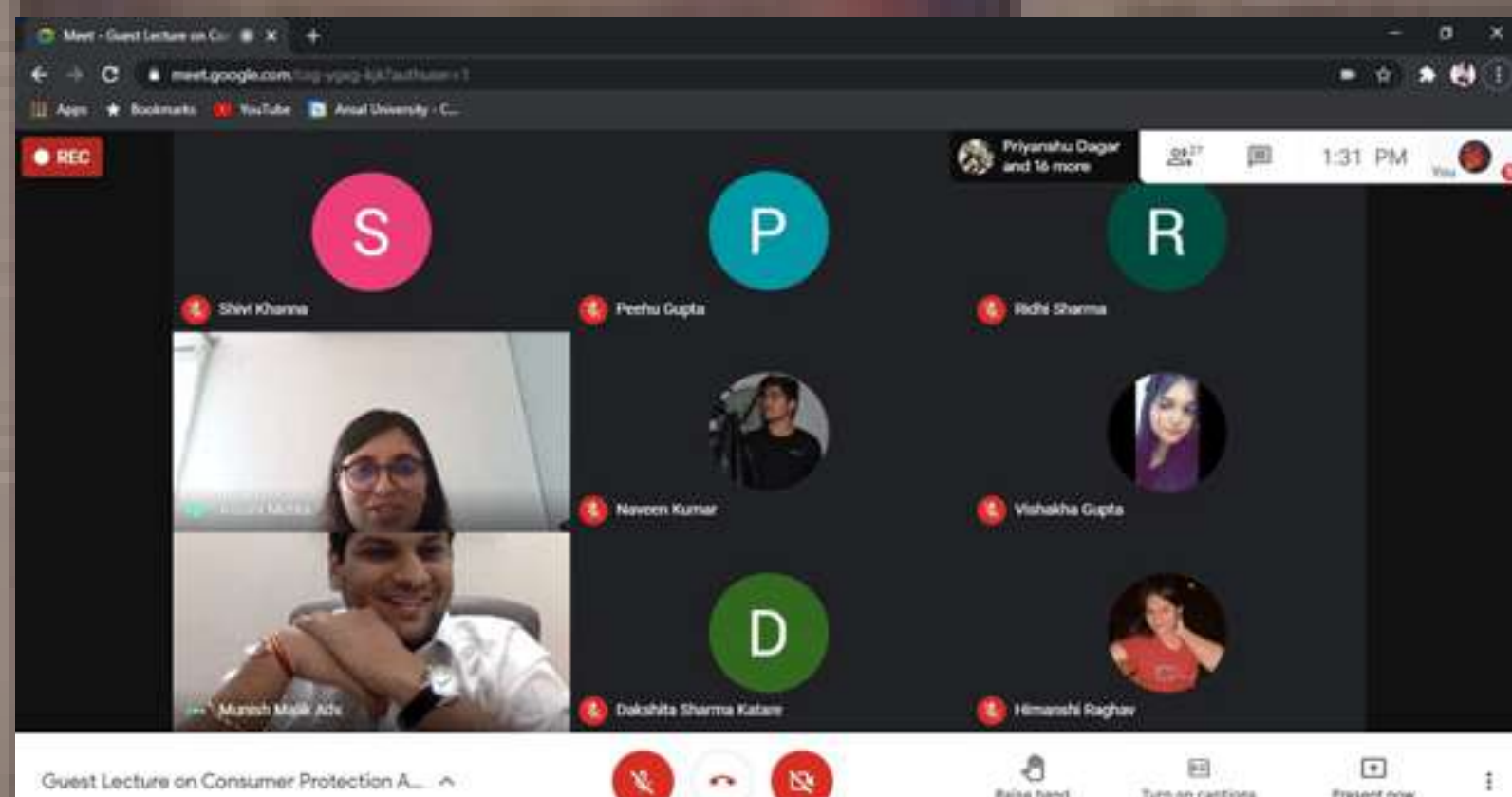
Guest Lecture on Consumer Protection and Complaint Drafting

Apart from practicing at District and Sessions Court of Gurugram, he is also pursuing Ph.D. from the aforementioned institute.

He briefed the students about the provisions of the Consumer Protection Act, 2019, compared its provisions with the repealed statute Consumer Protection Act, 1986 and illustrated the process of consumer dispute redressal along with the concept of defect and deficiency with examples.

He also taught the students the procedure to draft a complaint by using a real-life case and its already drafted complaint and explained each and every component of the complaint in detail.

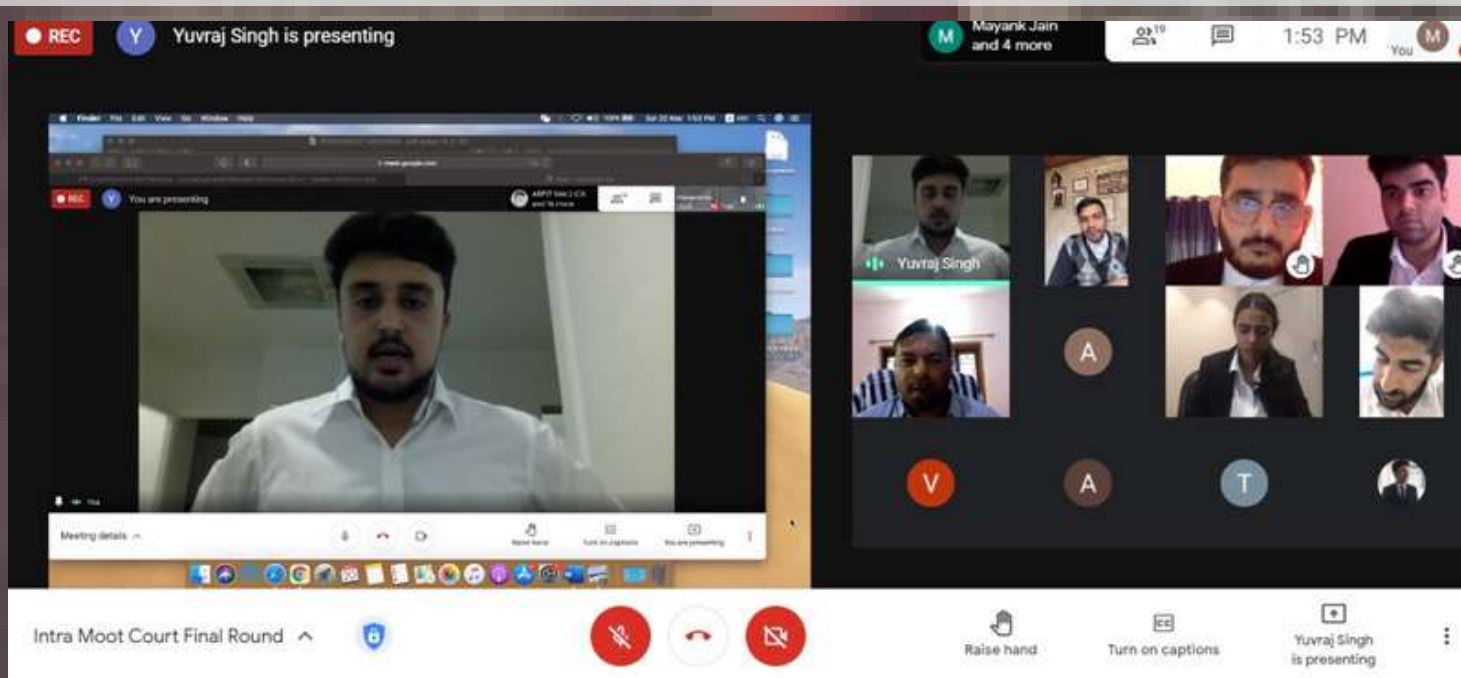

Faculty Development at School of Law

A Faculty Development Programme on 'Medical Negligence and Law' was conducted on 15th February, 2021 by Mr. Vipul Gaur, Assistant Professor of Law, Sushant University. With growing advancements in the medical profession, the cases of medical negligence have also increased. After the judgment of Supreme Court in *Indian Medical Association v. V.P. Santhara*, cases are also filed under the Consumer Protection Act, 1986 seeking compensation for the negligent act allegedly committed by the doctors." The FDP seeks to understand the cases of medical negligence and the law prevailing on this.

Prof. Amit Singh, School of Law conducted a highly engaging and informative Faculty Development Programme. In the session, Prof Amit reflected on the relationship between law and morality. Prof Amit further explained that the Hindu system is based on hierarchy. The typical challenge for religious and legal systems is to move from a system of hierarchy to universal equality. 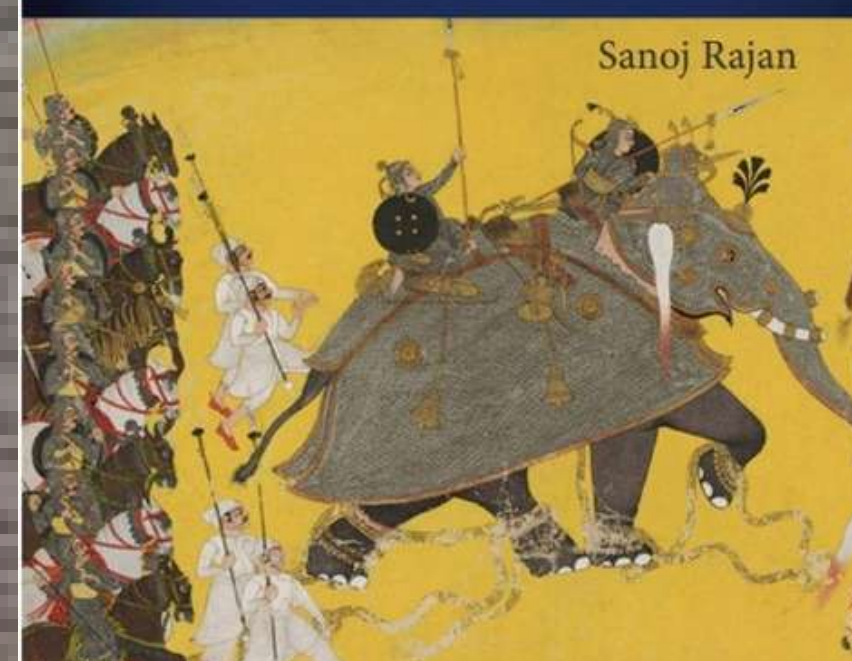
