
Plantation Drive (Rotaract Club)

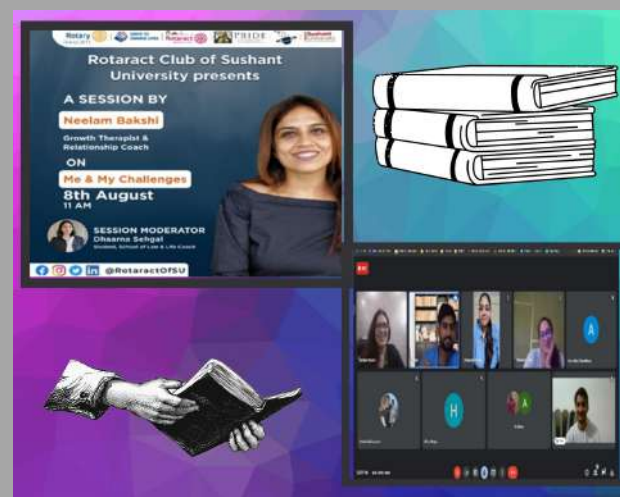
Career Insights Legum!

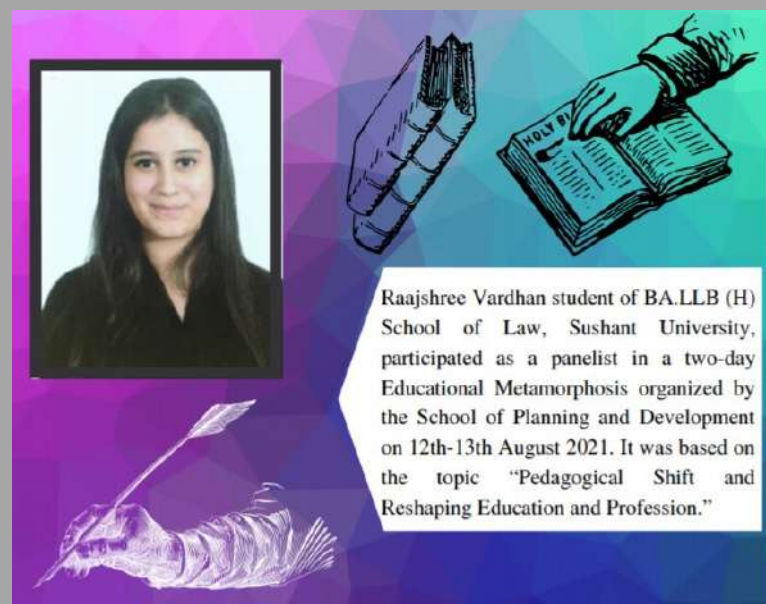
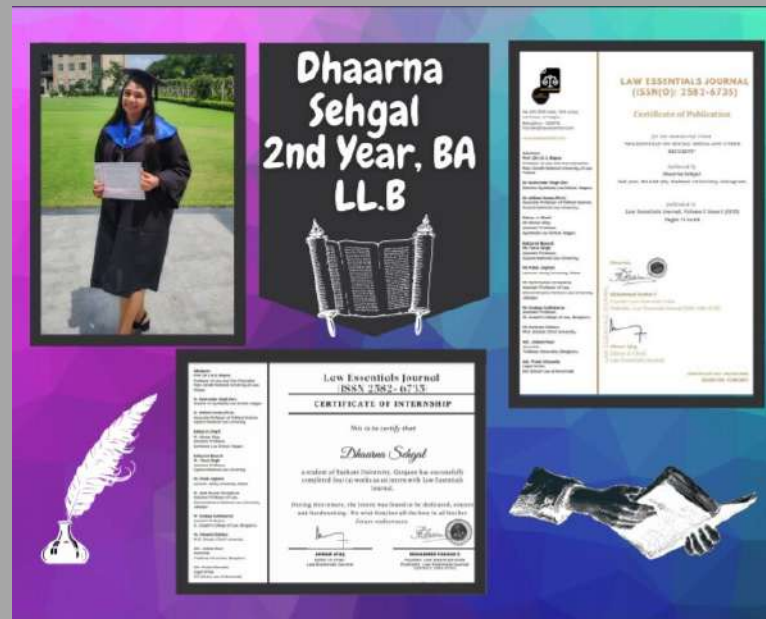
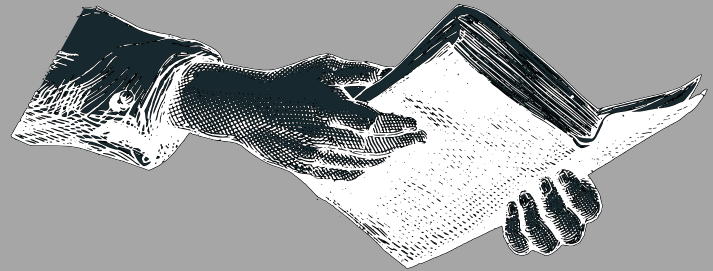


1st Sushant University Negotiation, Mediation and Client Counseling Competition 2021
