



LEGAL AWARENESS CAMP BY SUSHANT LEGAL AID CLINIC





The importance of the petition being complied with the test of reasonableness and challenging the action of authority was also highlighted. The students have gained critical drafting skills to draft a writ petition.


Student's Achievement



Amit Sachdeva student of LLB 1ST year has started an initiative called 'Project Compassion' in Indian jails.



He has have started 'Project Compassion', where he is conducting motivational talks for inmates specially from 18 to 21 years of age, most of them are first timers and feel so alone and at the same time those guys are so vulnerable and have to be safeguarded before they become hardened.




