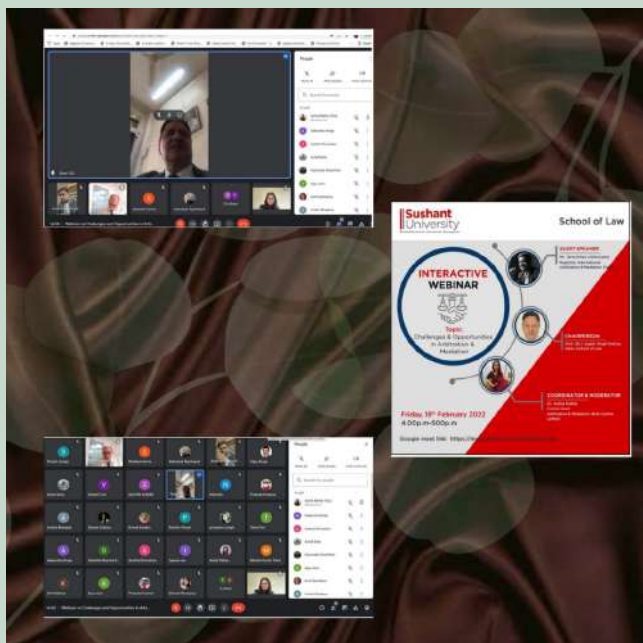
LEGAL AID CAMP BY SLAC

The attendees had lot of questions ranging from how arbitration and mediation has proved to be effective in dispute resolution to exploring internship opportunities and making a career out of Arbitration and Mediation in India and abroad.

He brings in his incredible experience to the class and makes the understanding of the laws easier for the students by adopting innovative pedagogy. The session was followed by Q&A where students intrigued by the lecture took career advice from Prof. (Dr.) Dawra.

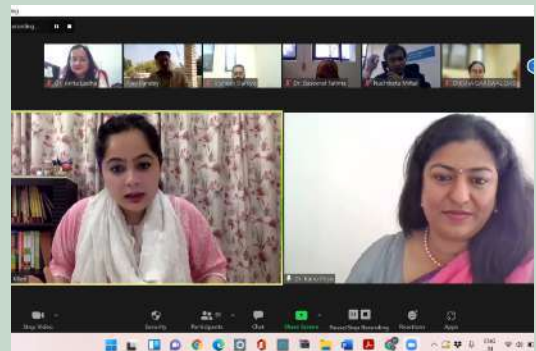
Faculty Achievements

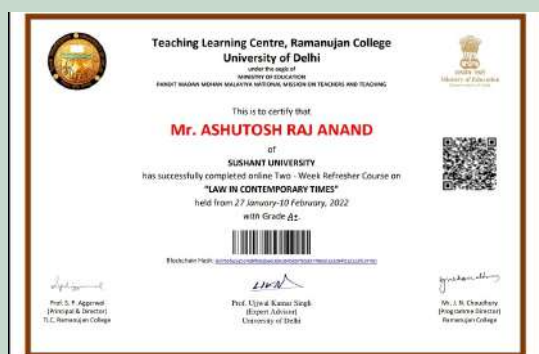

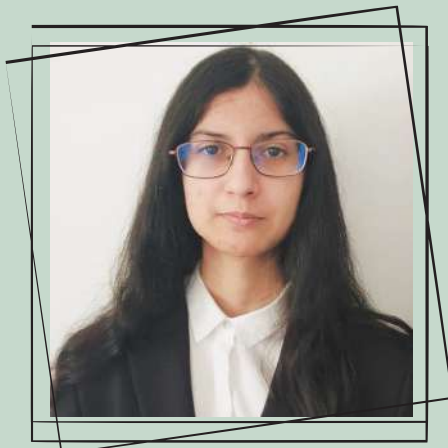

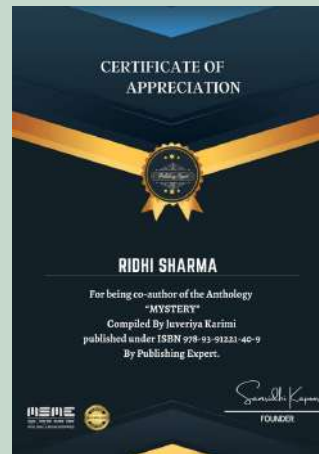
