WORKSHOP ON DRAFTING BAIL APPLICATIONS

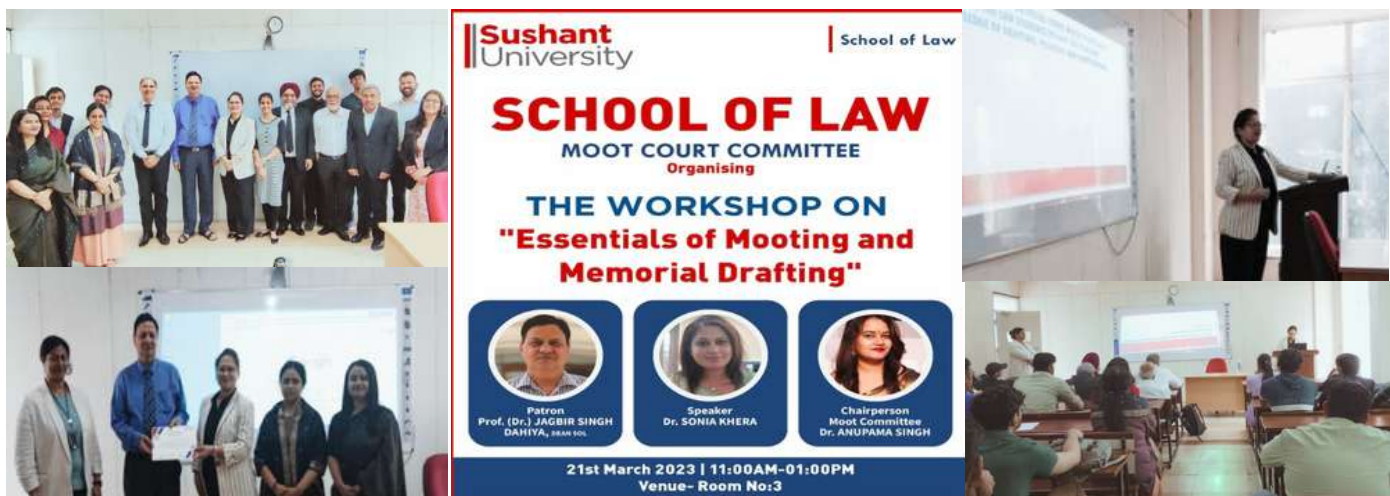


The Moot Court Committee of the School of Law at Sushant University hosted a Workshop on "Drafting Bail Applications" on 17th March, 2023.

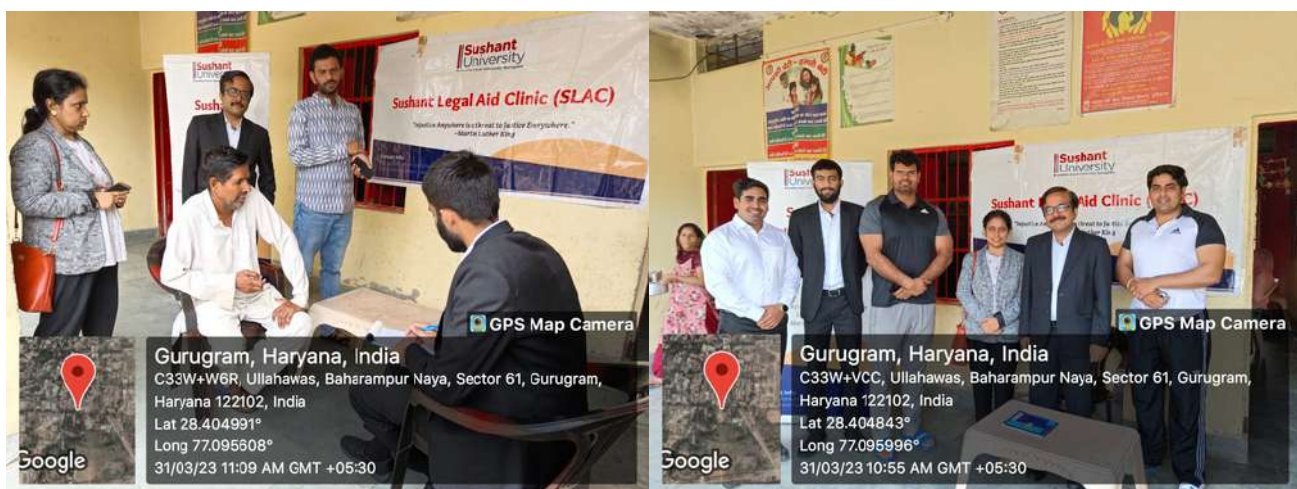
RESUME AND PORTFOLIO WRITTING
