AULAC (Ansal University Legal Aid Clinic) members organised a visit to Nathupur Village . The agenda of the session was to spread basic awareness among the people about their rights and to do some groundwork regarding the problems and issues faced by them.

The committee members spoke to the children and adults of the village after which we got to know about the problems they have. It was observed that they lack the most basic amenities specifically related to housing. Along with this, other issues were unhygienic lifestyle and unemployment. Basic rights relating to education, labour and safety were also spoken about. The aim of the consistent and continuous awareness sessions are to enable them to lead a happy, safe and healthy life.





Legal Awareness Programme in Bhondsi Village

Date: 28.02.2020

Ansal University Legal Aid Clinic organised a legal awareness programme in Bhondsi Village located in Sohna Tehsil in Gurgaon District of Haryana State and also in Government Senior Secondary School located in the village on 28th of February. The Legal Aid activity was targeted to approximate 1000 people as audience.

Ansal University Legal Aid Clinic (AULAC) conducted Social campaigns related to health, sanitation and hygiene, Legal Awareness regarding Domestic Violence and child labour, Castes, basic fundamental rights to invest efforts to educate the community through a variety of communication tools, and distributed various useful material.

We also have distributed sanitary napkins to make them aware and taught them how to use them.





Legal Awareness Programme in Gurgaon

District Court

Date: 24.02.2020 to 28.02.2020

In association with District Legal Services Authority (DLSA), Gurgaon. A continuous legal awareness cum support programme in District Court Gurgaon was organised. Students were deputed each day for helping the DLSA advocates on the helpdesk in the court premises.

The target audience were litigants. The students were asked to be present at the helpdesk from 9 am to 5 pm everyday. The students attempted to connect them to the advocates associated with District legal Aid Services. They were made aware of the free Legal Aid Services provided by DLSA. Many people came up with issues. The students discussed the possible available solutions with the distressed people. People were also informed about their basic fundamental rights and duties. General support related to case filing and paperwork was given.





Legal Awareness Programme in Bhondsi Jail

Date: 5.03.2020

On this visit our agenda was to appraise them of their rights so as to give them a meaningful existence as contemplated under article 21 of the Constitution of India.

They are particularly the most vulnerable sections of the society who don't even have the basic education nor facilities in order to make them aware of their rights. Right to know is an important facet of freedom of Speech and Expression.

Mr Deepak Kunwar, Phd Scholar in Ansal University, addressed the gathering of prisoners and appraised them of the rights provided in the constitution and other acts which includes Right to meet friends and consult lawyer, Rights against solitary confinement, handcuffing & bar fetters and protection from torture, Right to reasonable wages in prison and so on.

The students of Ansal University Legal Aid Clinic presented a nukkad natak addressing more than 500 prisoners as audience. . The event was much appreciated by the targeted audience as well as the jail authorities.

NEKI KI DIWAR-

A Wall of Kindness was set up near gate number 2 of Sector 55 in Gurgaon, to help underprivileged people who find it tough to make ends meet. The Wall of Kindness or 'Neki ki Deewar' is a concept in which hooks or hangers are put up on a wall designated for the purpose and people leave clothes for the needy. This **model of donations** is followed around the world and is fast gaining popularity in India. The site in Sector 55 was decided on due to its proximity to various commercial offices, and a heavy footfall of people every day. The initiative is being taken up by AULAC (ANSAL UNIVERSITY LEGAL AID CLINIC SET UP IN ANSAL UNIVERSITY, SCHOOL OF LAW). Members associated with the campaign said they aim to inspire people to participate in the Legal aid awareness and social service initiatives. The initiative has a theme—'**If you don't need it, leave it. If you need it, take it.**'

Assistant Professors Dr. Deepak Miglani and Dr. Komal organized a field activity under its AULAC program for B.A LL.B (Hons) 3rd year students to Bhondsi Jail on 27 February 2019.





First Legal Care & Support Centres handed over by District Legal Services Authority, Gurugram to School of Law, Ansal University

School of Law, Ansal University under the umbrella of Ansal University Legal Aid Clinic (AULAC), in its mission to impart social justice and nurture their students with social inclusivity has adopted two Legal Care and Support Centres: Protection office, Mahila Thana, Sector 51 and at Counsellor Office, Arjun Marg, DLF phase 1, Gurugram. The Centres were officially handed over by Sh. Narender Singh, CJM cum Member Secretary, District Legal Services Authority, Gurugram today at Mahila Police Station, Sector-51, Gurugram. Prof. Kanu Priya and Dr. Komal along with the team of PLVs and student members of AULAC from School of Law, Ansal University took over the charge and allocated the duties to the students to coordinate with the Police Incharge and Protection officer in providing counselling services and redressal mechanism to the women complainants and other distressed people.

Law students to give legal aid to the needy

Gurgaon: District Legal Services Authority (DLSA) has tied up with law faculty of five universities in Gurgaon to help run legal care and support centres in a more proactive way. The universities DLSA is partnering with are Ansal University, KR Mangalam, SGT (Shree Guru Gobind Singh Tricentenary University), IITM (Institute of Information Technology and Management) and GD Goenka University.

The law students of these universities will visit centers and provide free legal aid to people from underprivileged backgrounds and also improve legal literacy in the masses. For instance, the law students of Ansal University have begun providing counselling at one such centre being run at the women police post at Sector 51 every Wednesday and Saturday from 3pm to

6pm. Earlier, para-legal volunteers would provide legal aid to those who needed it but that was not done on a regular basis. DLSA secretary, Narender Singh told TOI, "The law students are going to be advocates and judges in future, who must be aware of the problems which public faces day to day. So the future legal experts must be able to facilitate legal solutions to such issues. Our centers provide students with exposure and opportunities and serves the purpose of providing free legal aid and education to the masses."

According to Singh, these centres were created to provide free legal awareness, counselling, and aid to the poor and needy. The process of creation of these centres began in 1995 when they were known as Legal Literacy Clubs but later renamed as Legal Care and Support Centres in 2012 when a regular officer, secretary to DLSA, was also appointed.

Representatives of AULAC will visit and provide free legal aid to the downtrodden and distraught members of the society. AULAC will also conduct research relating to the procedure being adopted by women police officials in dealing with complaints and attempts for amicable redressal of disputes. School of Law is the first Law School in the state of Haryana to adopt such Legal Aid Centre and join hands with the District Legal Services Authority in furtherance of its objective to impart social justice.

AWARENESS PROGRAMME ON SEXUAL HARASSMENT AT WORKPLACE IN ANSAL UNIVERSITY

An awareness program on “Sexual Harassment at the Workplace” was organised by AULAC in Ansal University on April 4, 2019. Eminent Supreme Court advocate and founder of the popular YouTube channel “Hamara Kanoon”, Ms.Avani Bansal addressed the students, faculty and staff of the university on the topic of sexual harassment. In her speech, she discussed the modern contours of sexual harassment and how it has become an all pervasive nuisance fostered by an environment of silence and acceptance. In an interactive session with the audience, Ms.Bansal demonstrated how most victims and survivors of sexual harassment resort to silence due to being unable to speak up for themselves and indicated that such silence is dangerous to society. She talked about the importance of communal support for victims of sexual harassment at the workplace or elsewhere.
