## NOTICE – Special Provision of Examination in Summers for Not-Promoted Category Students

March 29, 2023

As per the notification dated 29 September 2022, the concept of Summer Examinations has been discontinued for the non-graduating batches. Non-graduating batches need to clear their backlogs during the normal Odd and Even Semesters along with their regular semester assessments.

Students who have pending back papers even after multiple attempts and not meeting the requirement of promotion have been approaching University to conduct special exams for them in Summers such that they do not end up putting in an additional year in order to promote to the next year.

In order to facilitate the students, it is hereby notified that the University would conduct Not-Promoted-Category-Examinations (NPCE) as per the details mentioned below—

- 1. NPCE Reappear / Back paper exam (external component only) for Not-Promoted Students External Examination would be conducted for desirous students who are not meeting the requirement of promotion to the next year. Such examination are being conducted only for genuinely deserving candidates and merely by paying Fee does not make students eligible for NPCE Examination. Use of NPCE Examination is discouraged and may only be used in case of real need and protect the future of students. A fee of Rs. 5000 per paper (single component) is decided to be levied to cater to academic, Administrative and logistic expenses. (If the external Examination has separate theory and practical component exam then payment would be Rs 10,000).
- 2 NPCE Repeat exam (Compulsory & Optional) with Guided Self Study Course [GSSC] for Not-Promoted Students – This is applicable in case of -
- A) If the previous exam result status is Debarred (DB) due to attendance (all programmes)
- B) Any student who has failed a subject and who wants to improve upon their previous internal marks need to repeat the course (Not applicable for the B.Pharm)
- C) Exam result status Debarred (DB) due to less than pass marks (50%) in internal (applicable only for B.Arch- upto 2019 batch admissions)
- D) The faculty allocated for the GSSC has to certify and submit to the exams office that the student has met all requirements for the GSSC. Faculty shall maintain and monitor the logbook for attendance and shall note the student

interactions. Minimum ten interactions per subject are required. This shall be accounted for a student's minimum requirement of attendance i.e. 75% during the Summers for above categories for the student to be eligible to take the exam. In this case the student's previous internal marks shall stand null and void and only the current internal & external marks would be considered.

- E) The fees for the same would be Rs 15,000 per subject/paper.
- However, student would not be permitted to take all papers in Summers but only the minimum subjects required (plus one as additional backup) in order to meet the Promotion Criteria. For example, if a student has five backlogs of the First Year subjects and need to clear at least two of these subjects to meet the Promotion criteria for going into Third Year then the student would be allowed to take a maximum of three subjects only i.e. two in order to meet the criteria and one as an extra subject so that if student fails in one subject out of three s/he still meets the promotion criteria.
- However, B.Pharm programme may conduct their Reappear examinations for non-graduating students in Summers to accommodate minimum number of attempts to clear a paper as prescribed by PCI norms. (not applicable to other programmes)
- Students need to wait until the Promotion List is announced after the results of the Even Semesters before approaching the Exam Office for seeking the option of NPCE.
