School of Law Programmes 2021

B.A.LL.B (Hons.)

Duration: 5 Years - Full Time

Eligibility: Overall aggregate of 50% marks in 10+ 2 standard or equivalent examinations along with CLAT / LSAT / AILET scores. Candidates who do not have CLAT/ LSAT / AILET score will have to take Sushant University Law Entrance Test (SULET). Candidates expecting their result in 2021 may also apply.

B.B.A. LL.B. (Hons.)

Duration: 5 Years - Full Time

Eligibility: Overall aggregate of 50% marks in 10+ 2 standard or equivalent examinations along with CLAT / LSAT / AILET scores. Candidates who do not have CLAT/ LSAT / AILET score will have to take Sushant University Law Entrance Test (SULET). Candidates expecting their result in 2021 may also apply.

LL.B. (Hons.)

Duration: 3 Years - Full Time

Eligibility: A candidate applying to SU LL.B. 2020 needs to have a graduate/ post-graduate degree from any recognized university with at least 50% marks or an equivalent in any discipline. Candidates expecting their result in 2021 may also apply. There is no age bar to apply for SU LL.B. 2020 as per the Supreme Court's stay on age bar in 2017.

LL.M.

Duration: One Year - Full Time

Eligibility: Three or Five Year LL.B. Degree from any Indian or Foreign University recognized by the UGC with at least 50% marks or equivalent grade.

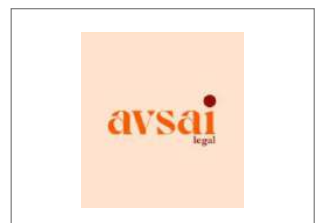
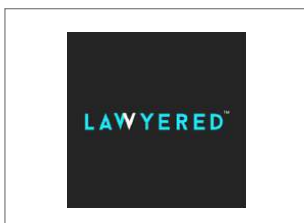
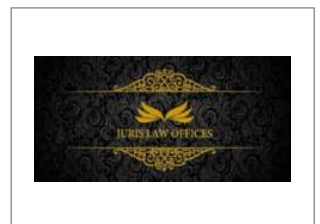
