1. Word limit: 2000 to 3000 words including Footnotes.
2. Font size:
 - a. For Headings – 14 (Bold)
 - b. For Sub-headings – 12 (Bold)
 - c. For Footnotes – 10
 - d. Other – 12
3. Font Style (for Footnotes & Body): Garamond/Times New Roman.
4. Line Spacing: 1.5
5. Footnoting Style: Harvard Bluebook 19th Edition or above.

6. Participants have discretion over the structuring of the Article. However, there must be a cover page consisting the following heads:
 - a. Sub-theme under which the Article has been written.
 - b. Title of the Paper
 - c. Name of the Author
 - d. Affiliated Institution
 - e. Course & Semester

Any deviation from the abovementioned criteria will lead to disqualification.
