This is to state that the M. Arch (Urban Design) Program at 'School of Art and Architecture', Sushant University has taken up Local Area Planning Projects jointly with URJA Delhi (United Residents Joint Action of Delhi) for various municipal wards of Delhi NCR, keeping in mind the larger good for the region.

A Local Area Plan (LAP) sets out a strategy for the proper planning and sustainable development of a specific area/ward with a public participatory approach. These two bodies wish to come together to promote, facilitate and implement these LAPS.

Both organizations have worked on LAP's for Gurugram in the year 2017-18 & 2021, Shivaji Marg in 2018-19, Lajpat Nagar 2019-20, Vasant Kunj in 2022 and Mehrauli in 2023.

The partnered institutions provided the professional knowledge support to do these LAP's with the institutions of architecture and urban design M. Arch (Urban Design) Program.

Each project's worth is estimated at approximately above Rs.10,00,00,000/- (Ten Crore) as the projected cost for the project implementation and the work done undertaken by the institute was estimated to the cost of approximately Rs.8,00,000/- to 10,00,000/- (Eight to Ten lakhs) per project. The work included as listed below:

- A) An in-depth documentation, study and analysis of the wards.
- Land Use Zoning, built use & density analysis
  - Open Space system analysis
  - Sustainable strategies
  - Movement system analysis
  - Provision of physical and social Infrastructure
  - Conservation of Built Heritage
  - Conservation of Natural Environment and systems
  - Design & Development Standards.
  - Legislation and Governance
  - Environmental protection
- B) Public meetings to empower the people and gain the local knowledge of the issues in the wards.
- C) The outcomes of the meetings in the form of a people's plan. Further to which vision and strategies for the areas using the tools and approaches of urban design were formulated.
- D) A detailed structure plan showcasing urban design approaches and proposed detailed design interventions for various sites within the area.

With this and many more such ways, this joint association/ partnership between the 'School of Art and Architecture', Sushant University as an institution and URJA -United Residents Joint Action of Delhi aims to empower the communities, make them more informed and involved in the development of their wards.

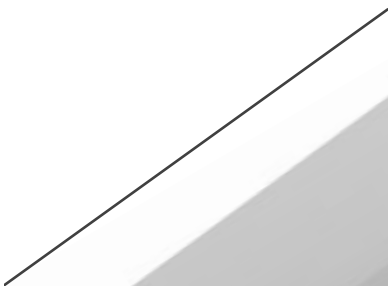

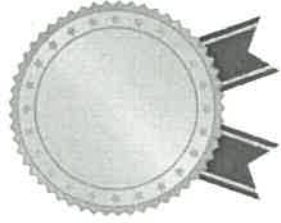
