Guidelines for Submitting Research Papers

Research Papers will be accepted on their originality, structure, research methodology and findings. Authors may submit case studies as well. The paper should not exceed 10,000 words and must be accompanied by an abstract (about 150 words), brief bio data of the author (s) and a declaration that the research paper is an original and unpublished work. Research paper should be typed in A4 page setup, with Times New Roman 12 size Font and 1.5 line spacing in MS Word. They should be properly formatted and inclusive of title, abstract, keywords, text and references (APA Style).

The research paper should be mailed to the Convener, IC-DES-2017 through e-mail at: **icdes2017@ansaluniversity.edu.in**. The Organizers reserve the right to accept or reject any work without assigning any reason.

Absentia

In case the authors wish to submit their in absentia, it is possible.

Presentation Guidelines

At least one of the authors needs to present their paper on the day of the event. The presentation will be through MSPowerpoint. Presentation time allocated for each presenter is 5-6 minutes, followed by Question/Answer round.
